# **Financial Reports**

The Financial reports for June and July were emailed to members on 25/08/23.

A summarized version was presented to the meeting by the Treasurer Amanda Winley. There were no questions relating to the June full year reports. Amanda advised that the financial year reports had gone to the Auditor and will be presented at the AGM.

Amanda alerted the meeting to several specific items;

- Profit and Loss for July 2023 and noted that the sum of \$7800 under Membership referred to the amount of invoices sent out to members, not to actual income received.
- Item "donations" as an expense relates to PBPA sponsoring the adjudicator and accompanist costs for the Scholarship Concert.

Amanda further explained the reduced July 2023 income as being the result of several very large expenses; namely the rates and hall insurance. Following a question from the floor, Amanda confirmed that the Hall insurance included Public Liability insurance. A further question about "income in advance" was explained by Amanda as people paying their bond to hire the hall. In general this would be refunded at the completion of the hire unless there was damage to the hall etc requiring the bond to be utilized.

## REPORTS SUB COMMITTEES

## Hall Management; Report - Victoria Crawford

Victoria thanked Jeanne Albrecht for her hard work on the sub-committee with her main role being to show people through the hall prior to booking. Victoria spoke to the following issues.



#### Hall refurbishment

- 1. Budget issues: Victoria explained that during the extended process of looking at insulations and paneling quotes the costs just keep increasing. She is in the process of obtaining 2 more quotes from recommended builders. Insulation and relining of ceiling prices have increased \$58,000 +GST.
- 2. Victoria has applied for a grant of \$100,000. On a standard building, a DA would not be needed to complete work. There is a question about the building being heritage listed and therefore possibly requiring a DA, meaning it is unlikely to be re-submitted and approved by November.
  - Victoria has however submitted an accompanying letter to explain the circumstances. If the application is unsuccessful on this occasion, we can seek a DA and reapply in November. She has organized to meet with the CCC Heritage Officer to seek advice.
- It may be necessary to repolish the floor prior to completing ceiling refurbish. VC
  has visited a large popular hotel which was polished with the same flooring
  method being considered.

VC has now spoken to another builder about resurfacing the floor with a type of oil finish.

Following a query from the floor, VC explained this would be 100% oil finish and not a blend.

4. Pest Inspection has been completed recently and found to have no current activity. However, there is an accumulation of boxes etc under the hall which need to be removed as they are a white ant attraction and also a fire hazard.

# **Events and Fundraising : Report- Gerarda Luck**

Gerarda discussed a list of events and community functions that were coming up over the next few months as well as the Financials for the Events in July and August . She asked those present to help support the Committee by volunteering at the community BBQ, which she identified as an excellent fundraising event as well as being a popular social get together. She also asked for volunteers to be "Santas".

## RURAL FIRE SERVICE AND COMMUNITY FIRE UNIT



Luke Stevenson spoke on behalf of the RFS. He said he has now become the Community Engagement Officer. He reminded members that we currently have a higher-than-average bush fire danger. He said we might be lucky this year, but eventually a fire will come.

Please take note of the new Bush Fire danger sign. When it says Catastrophic that's exactly what it means. It's a LOCAL forecast.

RFS is looking to update with an electric sign in due course.

He reiterated the need for more volunteers for the CFU who he reported remain part of RFS. He indicated that the CFU trailer may be "re-deployed" to another area if the group cannot maintain its operating numbers.

He reported that RFS had been called out to a number of burnt-out cars and automatic fire alarms going off.

The RFS will be holding it's annual "Getting Ready for Bushfires Day" on Saturday 16<sup>th</sup> September. The PB Brigade will be over near Jasmine Greens this year at Umina.

Luke reminded members that the PB Fire Station is open every Tuesday night. Community members can come and ask questions and seek advice and resources.

He also advised that there have been several prescribed burns around Kilcare causing excess smoke.

When asked about controlled burns in our own area, Luke reported these are administrative decisions based on perceived risks to communities. He added it requires a great many volunteers to manage a controlled burn.

Karina asked about the "blue cat's eyes" that PBPA had offered to purchase with RFS putting them in place along the roadside. Luke will follow up with completing this and ordering the required number.

Karina also asked about the issue of poorly maintained properties. Can the RFS indicate to owners that their properties are a danger?

This is not a RFS issue. Luke suggested 1<sup>st</sup> option should be to talk to your neighbors about decreasing the risk. 2nd option is to contact CCC about your neighbor's failure to maintain their property.

Karina also mentioned that PBPA would like to co-ordinate a thank you morning tea for the RFS. Details TBA

Phil Rich spoke about the important work these groups complete each month. Seven people met today at Paul Landa reserve and targeted asparagus fern. He advised



people to eradicate this weed from their own properties if possible as it spreads quickly.

He pointed out that unlike most other beachside environments our bush and dunes are much freer of weeds and toxic plants due to the persistent hard work and diligence of the bush and dune care groups. New helpers are always welcome.
