In the meantime, they advise if any resident has an issue with regard to excessive noise or problems with AirBNB rentals to contact their 24hr phone number.

# **Financial Reports**

The Financial reports for October 2022 were emailed to members on 26/11/22

The Treasurer, Amanda Winley reported on the :

October 2022 P&L; Year to Date, Cash Movement and Balance sheet reports. These were amended for simplicity.

There were no questions about the report.

Karina advised the meeting that a very generous donation (\$11,000) had been received from Thomas and Louise Fussell of Green Point Rd, and would contribute to the proposed refurbishments inside the hall. This donation was received very recently and therefore was not included the October financial reports.

Moved that the financial reports be accepted. All agreed

## **Prior to the Subcommittee Reports; Point of Order**

Malcolm McDonald requested to make a statement about the subcommittees. He made the following points.

- Acknowledged the validity of the AGM voting was in keeping with the Constitution
- Several new subcommittees have been formed and it was his belief they had not been ratified as shown in the Constitution.
- He also believes, there is duplication of already well working sub-committees
- He stated that minutes from previous GM and Executive meetings do not show they were ratified
- He believes that Sub-Committees cannot be formed by the Executive alone.
   Clause 26 (1) & that only a General Meeting can do this



- He cited Clause 27(2) and believes that each of the 4 new sub-committees need to be approved at the Executive (by vote) and then presented to the General Meeting with the Terms of Reference for each sub-committee
- He felt that correct procedure has not been followed
- It was his belief that any new sub-committee formed is deemed to be unconstitutional
- He asked that the result should then be put to the next General Meeting

Doug McDonald disagreed with some of the points raised by Malcolm pertaining to the constitution and Karina suggested these be reviewed after the meeting.

Karina spoke about the new sub-committees.

Fundraising and Community Engagement is not in competition with the previous Events committee (now renamed Publicity and Signature Events), but rather a supplementary committee.

Karina advised that this new committee had already raised a considerable amount of money, with new volunteers and new people in the organization working hard. It is aimed at visitors to the village who are open to spending money whilst on holiday in Pearl Beach. To that end a 'what's on in Pearl Beach' Facebook page has been set up to advertise to this group.

Two short term Committees were also set up;

- Constitution which should be reviewed every two years and has not been reviewed since 2018. Would have been due in 2020/2021, however Covid 19 intervened.
- Communication designed to formulate a uniform communication strategy for residents, ratepayers & visitors.

Victoria agreed that according to the Constitution the committees had not been set up properly and the Terms of Reference should be made available to the General Meeting to vote upon. She agreed that process should be followed. She suggested that the Constitution Committee could be called a <u>working party</u>, so that the committee could proceed with making recommendations.

Two members at the meeting spoke.

Naseema queried the process and agreed that process cannot be "put aside" but argued that the activities currently being undertaken were supporting the association. Kay spoke and suggested that the concerns presented were an "over reaction". She suggested that the "sub-committees" should be deemed 'Working Parties' until such time as they could be ratified.

She added that she believed the entire committee should be congratulated on their progress to date.



Karina asked those assembled whether they wished these committees to proceed, and highlighted the fundraising activities of the FACE committee to date She called for a show of hands which presented as well over the majority present in favour of all groups continuing as 'working parties' until such time as they could be voted on at the next Executive & General meeting.

She further advised that this issue would be discussed at the next Executive.

# **REPORTS**

# **Hall Management**

Capital works, Maintenance Hall Hire

Victoria Crawford reported that trees had been dead wooded, water pipes relocated, a faulty power point repaired, and new linoleum put down in the office. She advised the plumber is yet to provide his account, and the linoleum was approximately \$250. Thank you to lan Crawford for laying it.

Round of applause.

With the dead-wooding and electrician the total was about \$1,400.00. Karina and Victoria had been cleaning up the office this week. Currently in the process of reviewing storage arrangements.

The committee is currently reviewing the maintenance schedule and responsibilities such as rewriting and clarifying instructions for the stove and dishwasher. Peter Romey is updating the floor plan drawings. Paul Barclaire is investigating repair to the back door which may need to be replaced. A working bee is being organized to wash down the exterior of the hall. Victoria wished to also thank Margaret Moore, Barry Marks, Tony Maestri and Cooper for their hard work helping with landscaping and maintenance. Peter Richards and Lisa Marie Ritchie were to undertake the compacting of the crushed granite on Monday.

Future plans include sanding and resurfacing the floor, repainting Interior, possible refurbishment of the kitchen and reviewing storage arrangements.

# Safety Advisory Group

Paul Toohey updated progress with a number of current projects.

- Community Support Centre; Official opening 10am on Sunday 11<sup>th</sup> Dec; following Community Breakfast. The Spear point access remains an issue, with approval waiting and the annual cost being unacceptable. This is being followed up with letters to the Minister.
- Neighbourhood Alert Program has started.



A Street Contact meeting has been held with contacts being supplied printed material for distribution including 'Welcome letter' and neighbour alert information. Also, in the process of updating email contacts to provide easier contact in the event of an emergency.

#### Defibrillators:

Access has been simplified, no longer requiring a 'back to base system' which has been removed due to connectivity issues.

# Beach Safety:

No change with progress on the proposed walkway over the rocks to the rock pool. The pool will be cleaner prior to 10<sup>th</sup> December in preparation for the Christmas holidays. Awaiting a formal response from CCC re provision of a Lifesaver over the Christmas period and January school holidays. Stephen Parsons queried the availability of the Umina Beach Life Savers and was advised it would take at least 4-5 minutes for them to arrive at PB, plus telephone call time.

# • Community Fire Unit:

The CFU trailer has been repainted and refurbished. It is currently outside the hall. The main problem is it requires SIX active members to utilize this resource. Currently there are only FOUR. PLEASE CONTACT Paul Toohey or Lindsay Boyd (Brigade Captain) if you would like to volunteer for this essential service to the community.

# Speed Limit and Shared Use Zone:

This is still under consideration by CCC. However it was reported later by Peter Richardson (Convenor of External Liaison) that Liesl Tesch (local MP) had recommended that these two options should be split, as there would be a better chance of reducing the speed limit. This 40km limit has previously been approved for the Patonga Community. It was agreed that until a response was received from CCC nothing further would be done.

## **Publicity and Signature Events**

Lynne Lillico reviewed some past events including Remembrance Day, where a grove of rosemary bushes was planted to commemorate the restored War Memorial. The following people bought a rosemary bush in memorandum.

## **External Liaison- Government & Grants**

Peter Richardson outlined the proposed purposes of this potential committee.

- 1. To manage ongoing relationships with members of state and federal government and other relevant groups
- 2. To be the prime contact and to manage ongoing relationships with Central Coast Council (CCC), State and Federal Government with reference to:
  - i. Maintenance and improvement of our roads, verges, roadside drainage, and other infrastructure assets.
  - ii. Matters relating to safety, environmental, heritage and public health matters
- 3. To coordinate with and assist other PBPA groups regarding relationships with the above parties

Peter reported progress to date.



- Contact made with CCC Director of Infrastructure Services, Boris Bolgoff and others
- Recommended use of CCC Customer Service Centre for 'whole of community' reporting of issues relating to potholes, general roads maintenance, footpaths etc
- Coordinated approach with members to raise road and other defects and to monitor progress of rectification
- Agreed to check in with the Director within a month to discuss progress
- Met with Leisl Tesch to discuss support on several local and state government ongoing matters. (see SAG minutes)

He advised that in future he would like to meet and discuss progress on road defects and carry out a mini survey of roads in Pearl Beach. He intends to meet with CCC to discuss preventative maintenance and showed a map (available on CCC website) of the intended road repair in Pearl Beach, which at this stage is minimal.

# **Updating of PBPA Constitution and Guidelines**

Victoria briefly outlined the purpose of this proposed sub- committee. Having had one meeting, another is proposed for next week. Victoria asked if anyone had concerns relating to the Constitution would they please contact her on <a href="mailto:vfc1951@gmail.com">vfc1951@gmail.com</a>.

The committee/ working party intends to come to the March GM with suggestions and intends to finalise the document by May GM.
